

### 富衛旅遊保險保費7折優惠之條款及細則：

1. 富衛旅遊保險保費7折優惠（「此優惠」）只適用於透過 FWDGI.HK（「FWDGI 平台」）透過網上申請由富衛保險有限公司（「富衛保險」）所承保的富衛旅遊保險（「指定產品」）之情況。在此條款及細則下，客戶由 2022 年 8 月 11 日至 2022 年 12 月 31 日（包括首尾兩天）（「推廣期」）內透過 FWDGI 平台使用優惠編號「TRAVEL30」（「指定優惠編號」）以網上形式成功投保指定產品，可享受保費7折優惠（名額有限，先到先得）。
